- Well #7 has been running on its own and Well #6 kicks in 3-4 hrs./ day.
- Bob met with Tharp Brothers from McDonough Power who will start laying fiber optic lines soon via digging trenches & line-boring. Tharp Brothers asked permission from LSLSD to tap into the fire hydrants in order to use water to run their line-boring machine. Bob estimates it will cost them \$300-\$500 depending on the amount they use (cost runs about \$12/1000 gallons). Pat McKinley motioned to let McDonough Power use our water at the going rate. Bob Breen seconded. Motion passed. Bob will let Tharp Brothers know.
- Pat suggested we ask Tharp Brothers to give us a map of where the buried lines are so we will know for future projects. The company will start on the north side of the lake this fall and do the south side of the lake next spring.

Secretary-Treasurer's Report

- Pat presented the financial info. He reported that it's been a good year so far. Our well bond is down to \$82,488.68.
- Mat motioned to accept the Treasure's report. Bob seconded. Passed.
