## **Superintendent's Report**

- Larry reported on how we did during our recent storm. We didn't run out of water!
- During the storm, the existing control panel malfunctioned. We need a new one. Larry will get a quote.
- Since the storm it is clear we need to purchase a generator. Bob got a quote from Batson's for a generator \$9877.00 (installation & labor). Discussion continues about when to purchase it.
- The board is considering the purchase or rental of a propane tank (size to be determined) from Riden to run the generator to Well #7. The LSL Building Committee would decide where the tank will sit. Pipes can be run underground to other buildings. There is already a transfer switch. A long-term project would be to erect a separate structure for the chlorine.
- Bob reported that the chlorine pumps had quit working even though there was 20 gal. left in the tank. He performed a "McGyver" solution that got us through the storm days. He will keep more than 20 gal. in the tank from now on.
- Bob added there is still a problem on Mockingbird Ln no main shut-off has been located for the homes.
  Discussion continues seeking a solution to the problem.

## **Secretary-Treasurer's Report**

- Pat reported that finances are in good shape.
- The water tower inspection has been paid.
- Pat proposed that LSLSD pay off the #203 Bonds Well #7 loan of \$66,312.77 after the 22-23 Budget & Appropriations Ordinance has been published.
- Mat made a motion to pay off the loan. Bob seconded. Motion passed.
- Mat motioned to accept the Treasure's Report. Bob seconded. Accepted.
